Those who attended the November 19 annual retreat to develop an operating plan for 2017 agreed that this new year the Metropolitan Democratic Club of Seattle should focus on acting decisively to mitigate the damage the Republicans will surely attempt on a variety of issues including health care and climate change.

Although progressives are not happy with the results of the 2016 general election, we agreed, we must seize the opportunities that now abound to draw in others who understand that we are facing a great moral crisis and who want to get up off their apathy and “do something.”

We should all recall these words of Dante Aligieri, “The hottest places in hell are reserved for those who, in times of great moral crisis, maintain their neutrality.”

Our operating plan is meant to be anything but neutral. Its recommendations may not seem forward-moving on the surface, but we have breathed into them a desire to move forward in these ways:

- Further define our particular political identity
- Grow our membership
- Support our task forces

- McCleary

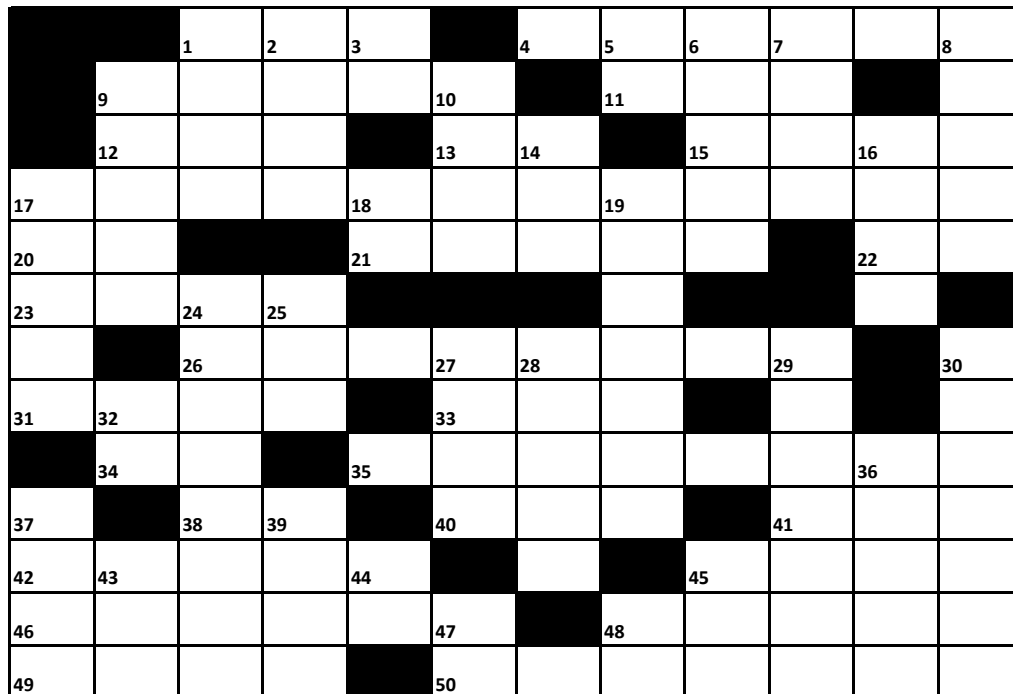

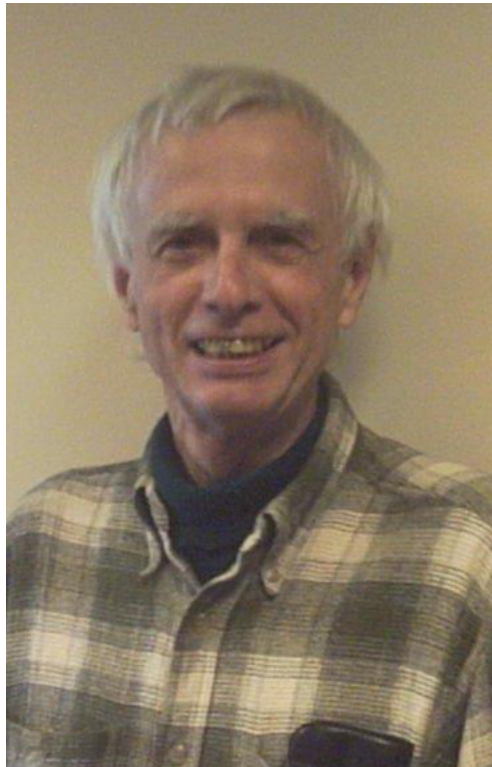

Whose votes count?

The effect of the Nader candidacy in 2000 in Washington State was that it sank Slade Gorton and gave Maria Cantwell her seat in the US Senate. She beat him 1,199,437 to 1,197,208, a difference of only 229, which was small compared with the 103,002 votes Nader got in Washington. The Green Party in Washington was very pro-Nader and considered Gorton to be public enemy number one, so it is likely Cantwell would have enjoyed a large share of the Naderite vote had he not been on the ballot. A Cantwell-Gorton advantage of only a third of one percent of the Nader vote was needed; that is, 229 out of 103,002.

Whereas the Florida vote is widely regarded as the decisive event distorted by the Nader candidacy giving the election to Bush-Lieberman, results in another state had the same effect. Nationally, Gore beat Bush 50,999,897 to 50,456,002, but that 543,895 difference was insufficient to reverse that in the electoral college, which Bush won 271 to 266. In Florida, Bush beat Gore 2,912,790 to 2,912,523, and this 267 vote difference gave Bush all of its 25 electoral votes. The 97,488 votes for Nader are believed to have hurt Gore more than Bush and are blamed for causing Gore's defeat in Florida. Also blamed was the perfidy of the US Supreme Court, which interfered with the recount underway there in November 2000 and gave the election to Bush.

Little noted, however, was the situation in New Hampshire, which was parallel to that in Washington. There Bush beat Gore 273,559 to 266,348 and won all three

electoral votes. Nader got 22,198 votes there, which was much larger than that 7,211 difference. If the Nader voters, had he not been on the ballot, would have gone, say, 50 percent for Gore, 10 percent for Bush, and 40 percent elsewhere including some not voting at all, Gore would have won 277,447 to 275,779. New Hampshire's three electoral votes would have tipped the electoral college margin from 271 to 266 for Bush to 269 to 268 for Gore.
