NPI advises on ballot measures

Andrew Villeneuve, founder and executive director of the Northwest Progressive Institute, opened his presentation to the Metropolitan Democratic Club of Seattle September 9th by describing the NPI as a strategy center that is revolutionizing grassroots politics. It helps activists bring about change primarily by teaching them reframing skills – changing the language they use so as to evoke progressive ideas in the minds of their audiences, he said.

Republicans have been practicing framing for decades, he said, and Democrats have fallen into the habit of the Republicans usage. The NPI strives to teach Democrats how to debate the issues on their own terms.

One of the NPI's activities is called Permanent Defense and it is aimed at Tim Eyman's "senseless and harmful schemes to destroy the government."

Mr Villeneuve went on to describe Eyman's Initiative 1366 that would eliminate funding for schools and other services unless the Washington State Legislature approves an (unconstitutional) amendment to the state constitution requiring a two-thirds vote to raise or recover revenue. The constitution requires a majority vote. His recommendation, obviously, was vote NO on I-1366.

Initiative 1401, he said, is aimed at raising the penalty for trafficking in wild animals and products made from them. Many progressive environmental groups support this measure. Villeneuve's recommendation on this issue was vote YES.

All of the Advisory Votes (10, 11, 12, 13) are on the ballot in the form of a nonbinding plebiscite as required by Mr. Eyman's Initiative 960. Most people don't know these are nonbinding, Mr Villeneuve said, and in fact, they are push polls and a waste of public funds. These tax increases passed by the legislature should be MAINTAINED, he said.

The King County Proposition 1, the Best Starts for Kids levy, aims to fund prevention and early intervention strategies to improve

Legends and lore

Regarding various findings of the history project committee

“A bunch of uppity downtown lawyers.”

This was an early description of the Metropolitan Democratic Club of Seattle that is still heard in some quarters when the MDC is mentioned. Even some members of the MDC are under the impression that the founders and earliest members were a bunch of lawyers. Some of them were. But many of them weren't.

The first extant list of members of the MDC was assembled in March of 1961. It listed each man's name (there were only men, then) and his profession or area of business. Here are some of the professions listed in addition to attorney: construction inspector, psychiatrist, physician, realtor, controller, insurance adjuster, architect, motel manager, travel agent, engineer, publisher, manager of the civic ice arena, court reporter, reporter, insurance broker, sales representative, restaurateur, contractor, county commissioner, assistant attorney general, transport and storage, budget director, teacher, real estate broker, manufacturer, chemist, camera retailer, property manager, public relations, stockbroker.

There were also many professors, mostly from the University of Washington. Probably the most widely known and admired was Dr. Giovanni Costigan. His name appears on the MDC membership rolls from 1961 to 1967.

Mr Costigan was born in 1905 in England of Irish parents. In 1926 he graduated from Oxford and in 1930 he earned an MA from that institution, then a PhD at the University of Wisconsin. He came to the University of Washington history department in 1934 and over the next 41 years taught English and Irish history. In retirement, he continued to lecture until his death at the age of 85 in Spain in 1990.

Emmet Watson, columnist for the Seattle Times, called him a courtly man, a poet with outrage.

He was outspoken and is remembered for his criticism of the war in Vietnam and his famous debate in 1971 with William F Buckley, which attracted 8,000 people to Hec Ed, a larger audience than the SuperSonics were able to draw.

Dr Jere Bacharach, who spoke to us August 12, was chair of the history department at the time Mr Costigan died. He described Mr Costigan as “an intellectual fighter for humanism and freedom.”

Dr Solomon Katz, whose name appears on the same MDC membership list as Mr. Costigan, and who was Dean of the College of Arts and Science at the UW at that time, said this about him in 1975, “These are the qualities that Giovanni has brought to us in his public lectures, his courses and his books and articles: careful scholarship, yes, but ever more than that, profound thought and in full measure, imaginative power, which enables him and us to recognize the relationship of values to fact, and above all, the compassionate understanding that history is about human individuals, each one unique, each one capable of greatness or villainy, sometimes both, each one acting or acted upon.”

the health and well-being of children. It saves money in the long range by decreasing homelessness, poverty, and infant mortality and thereby reduces the extent and cost of human services. Mr Villeneuve recommends a YES vote.

On both of Seattle's ballot measures, Initiative 122 (Honest Elections) and Proposition 1 (Move Seattle), Villeneuve recommends a YES vote. The former limits the influence of big money and the latter provides easier accessibility to light rail and increases rapid ride corridors.
