Sanders (Howell) wins debate with Clinton (Munro)

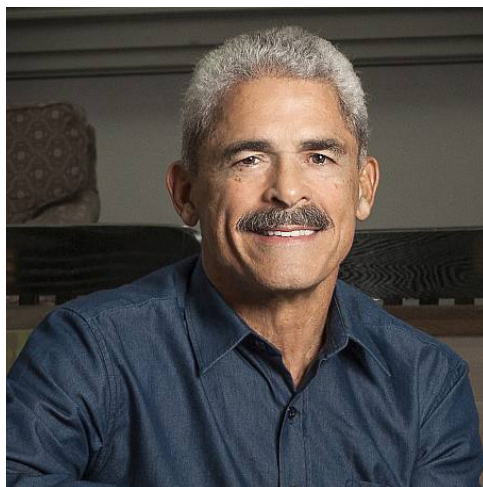
One a “schoolmasterly logician,” the other a “firebrand litigator,” according to Charlton Price, Lem Howell and Allan Munro respectively debated by proxy for presidential hopefuls Bernie Sanders and Hillary Clinton at the March 9 meeting of the Metropolitan Democratic Club of Seattle. Mr Price is an MDC member who heads the club’s Health Care for All Task Force. Senator Pete Francis was moderator for the debate and Bert Wyman was the timekeeper. The audience voted 10 to 9 in favor of Bernie.

Dan Fievez flipped a coin, Mr Howell called heads and won the right to decide who would speak first. He chose to have Mr Munro begin. Rather than attempt to replicate the constructive and rebuttal exchanges I will list the high points of each debater. Remember, the debaters have tried to put themselves in the shoes of the candidates and speak for them, not for themselves.

Dr Gayton talks about his fugitive slave ancestor

“None of us are responsible for the past, but all of us are responsible for the future,” Dr Carver Gayton concluded his presentation to the Metropolitan Democratic Club of Seattle March 9 about his book *When Owing a Shilling Costs a Dollar*.

The story is about Mr Gayton’s great-grandfather, Lewis G Clarke, who was born a “white” slave. Mr Clarke was the

prototype for the character of George Harris in Harriet Beecher Stow’s book *Uncle Tom’s Cabin*.

When offered the opportunity to buy his freedom, he said no one can own another person and that he belonged to himself.

He escaped from slavery and helped many others do so. He also became a leading spokesman for the abolitionist cause.

Mr Gayton has carried on the work of his ancestor. He earned his PhD in political science from the University of Washington. He served as Director of Affirmative Action Programs at the UW and was Executive Director of the Northwest African American Museum. He also was assistant professor of public administration at Florida State University and corporate director of educational relations and training at the Boeing Company.

Following his presentation Dr Gayton signed and sold books to members and guests.

Mr Munro provided some background. An awful lot rides on this 2016 presidential election: control of the US Supreme Court, Obamacare, the nuclear agreement with Iran, avoiding another boots-on-the-ground war in the Middle East, relations with Mexico, further reduction of greenhouse gas emissions, control of several US Appeal Court circuits, avoiding Republican austerity-strangling economic growth and more. Therefore the issue of electability becomes paramount.

Mr Sanders is a candidate with enormous vulnerabilities.

First, his political persona is undefined in the perception of most general election voters. The gives the Republican attack dogs the opportunity to define him in negative terms. Lee Atwater is dead, but Karl Rove isn’t.

Second, Mr Sanders is a self-described socialist. Socialism means state ownership of the means of production. This provides

book review

Nation on the Take: How Big Money Corrupts Our Democracy and What We Can Do About It

Unfortunately, I found this a tedious book to read. However, the message is urgently important. We the people have lost the democracy that was intended by the Constitution. Corporations and special interest groups increasingly control every level of government. They employ well-paid lobbyists, often former members of Congress, to peddle influence to their former colleagues.

Since corporations have a commitment to maximize profits, they have a natural dislike for government regulations and use all the influence they can to limit them. Unregulated, they may produce many harmful and unhealthy products. Thousands of chemicals in our environment are unregulated, and we don't know what effects they may be having on people, especially children.

Bernie Sanders has ably pointed out that the influence of money in politics is one of America's greatest problems. Our elected officials must raise huge sums of campaign cash. The average winning Senate seat in 2014 spent \$10.6 million. No wonder Congress gets so little done. Total money spent on Federal elections in 2012 was \$6.2 billion. Even most Republicans recognize this problem.

None of this is new information. What's shocking is that it gets so little attention in the media and so little protest from the people. There does seem to be a general sense in America that something is wrong. We hear it from voters in the current presidential campaign. But most of the people, despite their loud complaining, aren't focusing on the critical issues: the influence of money in politics and the drastically skewed distribution of wealth.

Teddy Roosevelt was the first to pursue campaign finance reform. Surely, the

time has come for the people to get aroused. Democracy requires reinvention and constant vigilance. It's time for a little rebellion, which Thomas Jefferson said is sometimes necessary and a good thing.

the republicans with the opportunity to stampede voters away from him from him. Specifically, small business class - a huge number of voters, entrepreneurs, and millennial generation libertarian techies. Moreover it is feared that over the years Mr Sanders has made statements in support on his socialist beliefs that will embarrass the Democratic Ticket.

Third, where is Mr Sanders team? He is being heavily criticized by mainstream economists for greatly overstating the economic growth and corresponding tax revenue from his fiscal and tax proposals.

His foreign policy statements are not definitive enough to outline a policy in places like the Middle East and Europe where we are engaged. I don't see any advisors with gravitas who are helping him lay out a comprehensive foreign policy. He has received very few endorsements from senators and congressman whom he will need to support his policies. He is not a Democrat. This huge country and government cannot be run by one man.

Fourth, his candidacy is not motivating key elements of the Democratic Party's coalition, such as Blacks and Hispanics. If these people don't vote in November, we will lose.

For these reasons, a Bernie Sanders candidacy presents clear risks of going awry.

Ms Clinton, on the other hand is poised to land running. For example she will need to deal with events in the Middle East and East Africa. The post World War I national boundaries, established by Churchill, David Lloyd George, Clemanceau and Orlando, are crumbling.

People are motivated by ethnic, tribal and religious loyalties, not national loyalties. There are many moving parts to our foreign policy. Our friends' enemies are also our friends. We are arming the Syrian Kurds while the Turks are bombing them. The Saudis are arming Sunni rebels in Iraq, including ISIS while we train the Iraqi army. This is causing a huge refugee problem in Europe, giving rise to right-wing racist parties.

Ms Clinton knows the territory and the players. She has developed an intuitive sense of how the US can achieve its policy goals without putting boots on the ground and without allowing terrorist enclaves to develop. It will be messy. It will have to be implemented on a case-by-case basis. But if anyone can do it, that person is Hillary Clinton.

In addition, Ms Clinton has detailed

The Devil's Chessboard; Allen Dulles, the CIA, and the Rise of America's Secret Government.

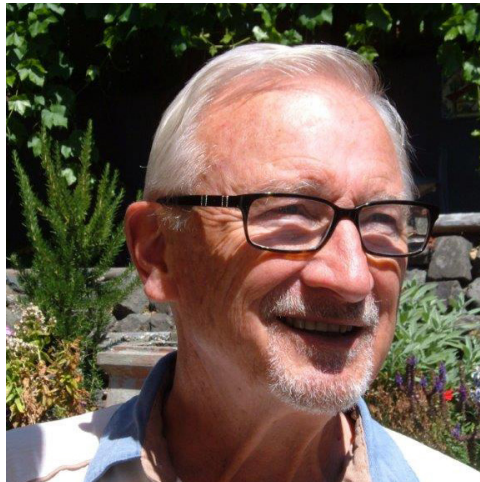

This book is very readable and well-documented. It is important for us to understand how terribly wrong our foreign policy has been and still is. Yes, I am talking about how we have overturned elections and cancelled the will of the people in country after country, including such examples as Guatemala, Chile, and Iran. Talbot argues that Arbenz in Guatemala was much like JFK – smart, young, liberal – so he had to be gotten rid of.

Much else is revealed in this book. The chapter on “little mice” shows how callously cruel Dulles was, throwing innocent and unsuspecting friends to the Soviets for them to lock up and torture, always in pursuit of the ultimate and highest goal, defeat of the communist menace.

If you hate to hear about conspiracies, avoid this book. The documentation is very thorough regarding CIA involvement in and control of the assassination of JFK, and probably of RFK. And who effectively ran the so-called Warren Commission, but good old Allen Dulles, allowed to investigate and cover up his own crime.

Do you remember Patrice Lumumba? Dulles could not stand the idea that Lumumba wanted to keep the Congo

neutral in the cold war – so Lumumba had to go. There is much to learn in every chapter of this book.

It is axiomatic that elected officials such as Congress and the president should be in charge, but it is obvious that at times it has not worked out that way. Allen Dulles is only one of the strangest, most sociopathic, and most powerful of the loose cannons who have stained our republic without the public's knowledge.

Read this book.

proposals: 1) amendments: Sarbanes Oxley and Dodd Frank, to reduce risk of another financial crisis, 2) stop inversions by multinational corporations to avoid US taxes, 3) require complete disclosure of sources of political spending, and 4) to achieve true gender equality from glass ceilings to women's right to choose.

Bernie's big issue will not be resolved just by taxing the rich. We need to overcome austerity and massively increase government expenditures for education and infrastructure.

Mr Munro is bothered by Mr Sanders opposition to the export-import bank. It benefits Washington state apple and fruit growers, wheat growers and music stand manufacturers. More than 30 percent of

Washington's employment is supported by foreign trade. This bank creates a level playing field for our exporters.

In response to Mr Munro's statement that Sanders is a very vulnerable candidate, Mr Howell said that Mr Sanders led all the Republicans in the polls. He quoted Mr Sanders as pledging to become a loyal Democrat and to remain so, at the time of he announced he was running for president last year.

Mr Howell stated that Mr Sanders voted against the Iraqi invasion and opposes “regime change.” Who are we to tell other countries what kind of government to have?” he asked. In addition Sanders voted

against the Patriot Act and voted against the bank bailout. He also voted against confirmation of Timothy Geithner as Treasury Secretary. He is opposed to Glass Steegall which Hillary voted for.

In addition Sanders supports universal health care and tuition-free junior colleges.

Mr Howell cited several new taxes Mr Sanders advocates. These included eliminating the carried interest loophole, which allows hedge fund managers trading in their own accounts to pay at a capital gains (reduced) level. Mr Sanders

also supports a tax on internet securities transactions .

Mr Howell pointed out that Mr Sanders has opposed trade agreements such as NAFTA and TPP that allow US jobs to be exported.

He said Mr Sanders does not have a financial PAC and criticized Hillary for accepting large contributions from Boeing. People don't trust Hillary, he concluded.
