# Two books on the economy

## The Great Divide

**unequal societies and  
what we can do about them**

By Joseph Stiglitz

Joseph Stiglitz argues with great force and clarity that large inequalities in income and wealth are a drag on economic growth as well as bad for the lives of people at the low end. Inequality is a product of society's decisions and can be rectified by enlightened government policies. Mr Stiglitz is critical of the Bush and Obama administrations for failing to prosecute the leaders of the too-large-to-fail financial institutions that took excessive risks, in some cases committed fraud, and almost brought the entire system crashing down.

Timothy Geithner covers much of the same ground in his biographical history of the period he was chairman of the New York Federal Reserve and after that, Secretary of the Treasury in Obama's first term. However, Mr Geithner, while acknowledging the rash conduct of US financial leaders, argues against prosecution, clawbacks and other punishments. He states this would have led to further panic and dysfunction in the financial system. He correctly makes clear that the welfare of the system trumps (excuse the pun) bringing the offending financial leaders to justice.

I feel that Mr Geithner, having gone through the financial crises while having system-wide responsibilities, has been overly traumatized by the specter of another panic. He shouldn't have been so strident when advising the president to avoid addressing the subject of moral hazard. Aggressive action to rectify moral hazard is a necessary example discouraging future reckless conduct. Nevertheless Mr Geithner's description of what causes financial crises and what to do about them is very well-reasoned and cogent.

Both books are aimed at lay audiences and are easy to read. I recommend them for those interested in understanding the most salient economic event of our time.

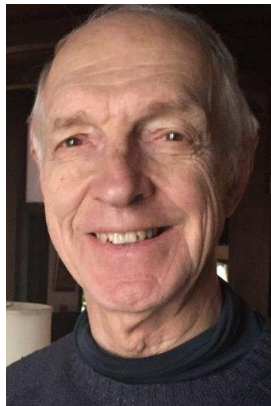

## Rail rectification builds head of steam

A last minute cancellation of one of the speakers, Representative Reuven Carlyle, scheduled to speak at the November 18 meeting of the Metropolitan Democratic Club of Seattle meant that the meeting was devoted to Patrick Mazza explaining solutionary rail.

Elizabeth Stanton, who organized the program, introduced Mr Mazza, who is owner of an MROC, an independent global sustainability consultancy that seeks climate solutions.

One problem that needs a climate solution, he explained, is rail transportation. He calls his solution solutionary rail. This involves rail rectification, meaning electrify and modernize rail. The results are worth the energy. For example, electrification of the main Burlington Northern Santa Fe mail rail line from Seattle to Chicago would allow higher average speed (120 mph for passenger and 100 mph for freight). Computer scheduling would allow accommodation freight and passenger on the same line.

Using renewable electricity generation would mean less carbon and less pollution, he claims, and railroads would be less dependent on bulk commodity transfer such as oil and coal.

Mr Mazza called for an interstate development bank to provide either a \$2B single-track system or \$2.5B double-track system. He says unions support this idea.

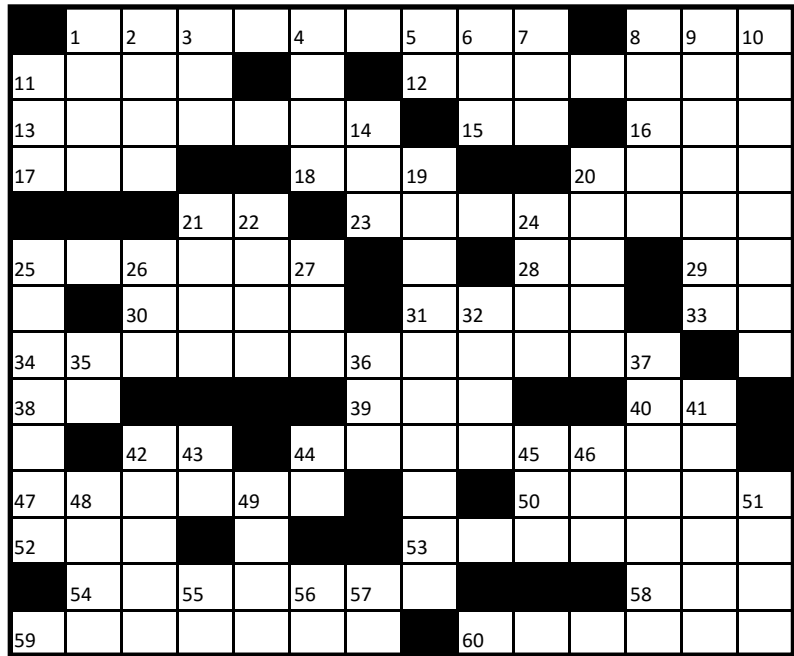
At the last legislation session, he added, a bill was introduced to provide Washington State University with \$250K for a feasibility study. The bill was sponsored by an eastern Washington republican.

Mr Mazza has produced many influential papers on emerging energy systems and national papers on agricultural clean energy. He has provided research and writing of issues pertaining to climate policy and sustainability. He co-authored *Stormy Weather: 101 Solutions to Global Climate Change*.

This is where containers go directly from ship to railroad flatbed vehicles and bypass the intermediate step of being trucked from dock to yard.

The commissioners also stated that T-5 will not be used as a hosting facility for the Shell arctic drilling fleet. Portions of the fleet will be harbored in Everett, though. The commissioners also cited the recent clean air performance of the Port of Seattle with shore-provided power for tour ships and a carbon dioxide reduction plan for all marine and truck traffic.

Shifting facilities, Commissioners Gregoire and Bowman discussed SeaTac International Airport and reminded everyone that this is the fastest growing major international airport in the US and has been for the past five years. There are plans to renovate and improve the north passenger facility and SeaTac has been working with Alaska Airlines on that major upgrade. In addition, the International Arrivals/Departures terminal is the oldest such facility in North America and now very much outdated and overtaken by a huge growth in international travel. Plans are underway to significantly enhance this terminal, and include such new environmental features as “facility air,” where aircraft at boarding gates can plug into SeaTac conditioned air rather than having to operate the aircraft’s Auxiliary Power Unit (APU) to provide air conditioning and power.

## Commissioners update the MDC on management of “north” and “south” ports

At the October 14 meeting of the Metropolitan Democratic Club of Seattle, Seattle Port Commissioners and Co-Presidents Courtney Gregoire (position two) and Stephanie Bowman (position three) presented a status update on the Port of Seattle’s maritime and aeronautics activities and future plans.

Commissioner Bowman gave a review of how the NW Seaport Alliance came into being and how this would be beneficial to the Puget Sound region. This historic arrangement combines the Port of Tacoma and the Port of Seattle maritime activities under a single management structure. By collaborating on port activities rather than competing, the new NW Port Alliance can effectively compete against the most serious competition we have on the West Coast - Los Angeles/Long Beach and Prince Rupert, BC.

The new alliance now identifies the Port of Tacoma as “south port” and the Port of Seattle as “north port.” The renovation and upgrade of North Port’s Terminal 5 is an important element in the competitive strategy of the NW Seaport Alliance not just because it’s a deep draught location with the shortest West Coast path to Asian ports, but because it has significant “on dock rail.”

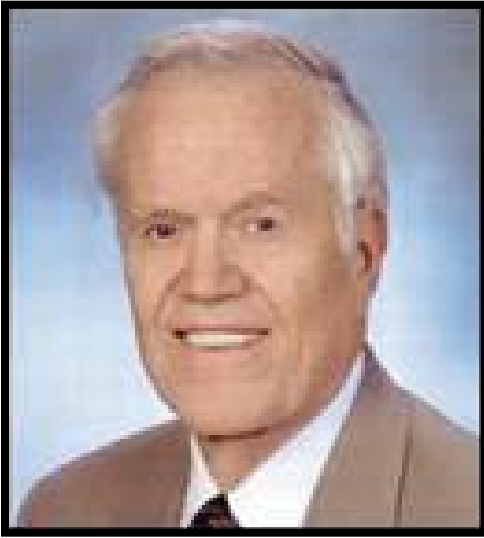

The airport management has also worked to develop a client list of truly local vendors within the airport concourse areas. The question of minimum wage support came up and both Gregoire and Bowman indicated that SeaTac already pays above that and the vendors will now be doing the same based on the recent judicial ruling. They also cited the Port’s emphasis on overall working conditions including child care, sick leave and an overall career path improvement.

Both commissioners responded to member questions and continued to cite the importance of the middle income jobs that both the seaport and airport provide to the local economy and how important it is to maintain an industrial area in SoDo. The airport expansion will occur within the existing SeaTac footprint. The recent conversion of flight paths to a GPS-based landing or takeoff has helped with lowering the fuel use of airlines which has benefited both the environment (lower emissions) and economic conditions of the airlines (lower fuel use).





### Payton Smith

Oct 1932 – Sept 22

Payton Smith died September 22 in Las Vegas. He was vice president of the Metropolitan Democratic Club of Seattle in 1965. The MDC membership rolls list his name from 1961 to 1967.

He was born in Fort Worth, Texas, graduated from Southern Methodist University and the University of Chicago Law School; and in 1957 moved to Seattle where he served as chief assistant US attorney for the Western District of Washington 1961-1963. He practiced law at the firm of Davis Wright Tremaine 1963 – 2011.

Mr Smith was obviously active in politics. He was a Kennedy delegate to the Democratic National Convention in 1960. He also served as president of the Young Democrats.

In 1997 his book, *Rosellini: Immigrant's Son and Progressive Governor*, a political history of Washington's Governor Albert Rosellini, was published by the University of Washington Press.

Memorial services were held in the offices of Davis Wright Tremaine on October 21, 2015. The family suggests donations to Plymouth Housing Group or Grace in the Desert Episcopal Church in Las Vegas.



The MDC will honor these members, now departed, at the club's Diamond Jubilee – promoting progressive values for 60 years. The date has not been set.



### Pat Emerson

Nov 1925 – Dec 2015

Having just celebrated her 90<sup>th</sup> birthday, Pat Emerson, first woman president of the Metropolitan Democratic Club of Seattle, died December 2, 2015.

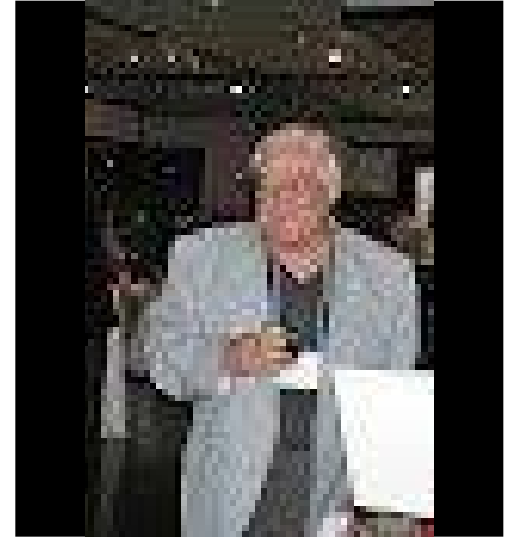
Ms Emerson was president from 1993 until 2001 after which she acted as secretary for three years. She had served in that capacity before having been elected president, too.

She was born in Wyoming and graduated from the University of Wyoming with a bachelor's degree in political science and language.

Her husband, Dick Emerson, was a mountaineer and sociologist who was a member of the first American expedition to Mt Everest. They moved to Seattle when he joined the faculty of the University of Washington. She earned a graduate degree in South Asian studies, which prepared her for years of research and teaching in Pakistan. After her husband died in 1982 she spent years living and working in Pakistan by herself, managing the Urdu Language Program in Pakistan for the University of California Berkeley.

Her involvement in local politics included serving as the president of the Seattle League of Women Voters, during which time she moderated panel discussions of public affairs and local issues for a weekly show on channel 9.

The family suggests a donation to the Asia Foundation or to the Juniper Fund as remembrances.



### Dave Wood

February 1930 – November 2015

Dave Wood was one of two remaining founding members of the Metropolitan Democratic Club of Seattle. The club honored him at the Gala 56 event in 2013 along with three other founding members. (Judge Robert Winsor is the remaining founder.)

At his advanced age he was able to hop on a bus in Shelton and make it to Seattle in time for an MDC meeting. He remained active in the organization to the end, talking on the phone to members shortly before his death.

Mr Wood was born in Tacoma, graduated from high school in 1948 and married Joyce Hunter the next year. He earned a bachelor's degree in journalism in 1952. During his university years he edited the UW daily newspaper and was a member of the Tau Kappa Epsilon Fraternity. Upon graduation he went to work as public relations officer for Bethlehem Steel. He joined the Society of Professional Journalists and maintained his membership for the rest of his life.

He used his profession to promote political figures and issues, working as campaign or government press secretary for Governor Albert Rosellini, Senator Brock Adams (MDC's first president), and Mayor Wes Uhlman. He also served as Mr Uhlman's deputy mayor.

Mr Wood worked as a lobbyist and communication instructor, and eventually moved to Olympia to work with the state legislator as a consultant and contract lobbyist. Many of those he served were developmentally disabled or families who were having their children removed from their custody.
